



BayPort Rewards Checking – Mastercard® Debit Card – Bill Pay Sweepstakes

Official Rules

1. Register online at www.bayportcu.org or in a branch when opening a Rewards Checking account using the promo code: Disney19.
2. Membership eligibility required. Members that open a Rewards Checking account with a Mastercard Debit Card online or in a branch using the promo code: Disney19, sign up for eStatements, enrolls in Bill Pay, and payment of at least three (3) bills a month through Bill Pay during any of the three (3) phases of the promotional period will be automatically entered to win.
3. At time of entry and drawing, entrant must be 1) a legal U.S. resident and 18 years or older, 2) a BayPort Credit Union member in good standing, and 3) a member with a Rewards Checking account enrolled in Bill Pay.
4. BayPort Credit Union employees and Board members, as well as their immediate family members, are not eligible.
